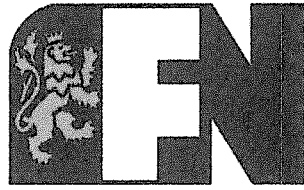

Approval in-principle from, admission to the Official List of, and the listing and quotation of the Series 15 Notes on, the SGX-ST are not to be taken as an indication of the merits of the Issuer, F&N, their respective subsidiaries (if any), their respective associated entities (if any), their respective joint venture entities (if any), the Programme or the Series 15 Notes.

The Series 15 Notes are expected to be admitted to the Official List of the SGX-ST with effect from 9.00 a.m. on 23 August 2017.
