**ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS**

**SUMMARY**

**Offer Price and Net Proceeds from the Global Offering**

- The Offer Price has been determined at HK\$1.98 per Share (exclusive of brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the final Offer Price of HK\$1.98 per Share, the net proceeds from the Global Offering to be received by the Company, after deduction of (i) the net proceeds from the sale of Sale Shares by the Selling Shareholder in the Global Offering, and (ii) the underwriting commissions and other offering expenses, are estimated to be approximately HK\$164.0 million, assuming the Over-allotment Option is not exercised. The Company intends to apply such net proceeds in the manner set out in the paragraph “Offer Price and Net Proceeds from the Global Offering” below in this announcement.

**Applications and indications of interest received under the Hong Kong Public Offering (including the Employee Preferential Offering)**

- A total of 39,356 valid applications were received for a total of 3,897,572,000 Hong Kong Offer Shares, equivalent to approximately 162.94 times of the total number of 23,920,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering.
- As the Hong Kong Public Offering was well oversubscribed, the reallocation procedures as described in the section headed “Structure of the Global Offering — The Hong Kong Public Offering” in the Prospectus have been applied. As the number of Offer Shares validly applied for under the Hong Kong Public Offering is more than 100 times of the number of Offer Shares initially available for subscription under the Hong Kong Public Offering, a total of 95,680,000 Shares have been reallocated to the Hong Kong Public Offering from the International Offering, so that the final number of Offer Shares under the Hong Kong Public Offering is increased to 119,600,000 Shares, representing 50% of the Offer Shares available under the Global Offering (before exercise of the Over-allotment Option and without taking into account the options which have been or will be granted under the Share Option Schemes).

- A total of 84 valid applications were received pursuant to the Employee Preferential Offering on **PINK** Application Forms for a total of 5,468,000 Employee Reserved Shares, representing approximately 2.29 times of the 2,392,000 Employee Reserved Shares initially available under the Employee Preferential Offering. As the Employee Preferential Offering has been oversubscribed, none of the Employee Reserved Shares was made available for subscription by the public under the Hong Kong Public Offering.

**International Offering and Over-allotment Option**

- The Offer Shares initially offered under the International Offering have been well oversubscribed. The final number of Offer Shares under the International Offering is 119,600,000 Shares, representing 50% of the Offer Shares available under the Global Offering (before exercise of the Over-allotment Option and without taking into account the options which have been or will be granted under the Share Option Schemes).
- The Company has granted the Over-allotment Option to the International Underwriters, which is exercisable by the Sole Global Coordinator on behalf of the International Underwriters pursuant to the International Underwriting Agreement at any time from the date of the International Underwriting Agreement up to Sunday, June 3, 2018, being the 30th day after the last day for the lodging of applications under the Hong Kong Public Offering, to require the Company to allot and issue up to an aggregate of 35,880,000 Shares at the final Offer Price to, among other things, cover over-allocations in the International Offering, if any. There has been an over-allocation of 35,880,000 Shares in the International Offering and such over-allocation has been covered through the stock borrowing arrangement under the Stock Borrowing Agreement between Hero Valour and the Stabilizing Manager. As at the date of this announcement, the Over-allotment Option has not been exercised. In the event that the Over-allotment Option is exercised, a public announcement will be made.

### **Cornerstone Investors**

- Pursuant to the cornerstone investment agreements with the Cornerstone Investors as described in the section headed “Cornerstone Investors” in the Prospectus, (a) Fraser and Neave, Limited will subscribe for a fixed number of 32,000,000 Shares at the Offer Price (representing approximately 4.42% of the Company’s total issued Shares immediately following completion of the Global Offering, assuming the Over-allotment Option is not exercised and without taking into account the options that have been or will be granted under the Share Option Schemes), and (b) the number of Offer Shares to be subscribed for by NH Foods Limited has now been determined to be 35,768,000 Shares based on the final Offer Price of HK\$1.98 per Share (representing approximately 4.94% of the Company’s total issued Shares immediately following completion of the Global Offering, assuming the Over-allotment Option is not exercised and without taking into account the options that have been or will be granted under the Share Option Schemes). As a result, the Cornerstone Investors will subscribe for a total of 67,768,000 Shares representing in aggregate (i) 28.33% of the Offer Shares initially available under the Global Offering; and (ii) 9.36% of the Company’s enlarged share capital immediately upon completion of the Global Offering, assuming the Over-allotment Option is not exercised and without taking into account the options that have been or will be granted under the Share Option Schemes.

To the best knowledge of the Company, each of the Cornerstone Investors and their respective ultimate beneficial owner(s) is/are independent of each other and the Company, and is not a connected person or an existing Shareholder or close associate of the Company. Immediately following the completion of the Global Offering, the Cornerstone Investors will not have any board representation in the Company, nor will any of the Cornerstone Investors become a substantial Shareholder of the Company. The shareholdings of the Cornerstone Investors will be counted towards the public float of the Shares. Further, the Cornerstone Investors will be subject to restrictions on disposals of their Offer Shares during the period of six months starting from and inclusive of the Listing Date.

Based on the final Offer Price of HK\$1.98 per Share, the net proceeds from the Global Offering to be received by the Company, after deduction of (i) the net proceeds from the sale of Sale Shares by the Selling Shareholder in the Global Offering, and (ii) the underwriting commissions and other offering expenses, is estimated to be approximately HK\$164.0 million, assuming the Over-allotment Option is not exercised and without taking into account the options that have been or will be granted under the Share Option Schemes, and the Company currently intends to use the net proceeds in accordance with the purposes set out in the section headed "Future Plans and Use of Proceeds" in the Prospectus, as follows:

The Company has granted the Over-allotment Option to the International Underwriters, which is exercisable by the Sole Global Coordinator on behalf of the International Underwriters pursuant to the International Underwriting Agreement. Pursuant to the Over-allotment Option, the International Underwriters have the right, exercisable by the Sole Global Coordinator at any time from the date of the International Underwriting Agreement up to Sunday, June 3, 2018, being the 30th day after the last day for the lodging of applications under the Hong Kong Public Offering, to require the Company to allot and issue up to an aggregate of 35,880,000 Shares, subject to the Hong Kong

Underwriting Agreement and the International Underwriting Agreement becoming unconditional, representing 15% of the Offer Shares initially available under the Global Offering, at the final Offer Price to, among other things, cover over-allocations in the International Offering, if any.
