"Acquisition" refers to the acquisition of 4,046,690 additional shares in the issued share capital of Vietnam Dairy Products Joint Stock Company ("Vinamilk"), a company listed on the Ho Chi Minh Stock Exchange ("HOSE"), by the Company's wholly-owned subsidiary, F&N Dairy Investments Pte Ltd ("F&NDI") by way of on-market purchases on the HOSE today. Settlement is expected to take place within 2 business days. Following the Acquisition, the Company, through its wholly-owned subsidiaries, F&NDI and F&NBev Manufacturing Pte. Ltd., will hold an aggregate of 289,601,056 Vinamilk shares, representing approximately 19.96% of the issued share capital of Vinamilk.
